Ladies and men's shower/restrooms were gutted and remodeled. Termite activity was detected upon gutting the shower stalls. Decision was made to treat entire Clubhouse complex for termites.

Carpet in the Clubhouse hallway plus lounge was removed and replaced with ceramic tile.

Most residents, to date, have been issued keyless entry devices for the clubhouse and pool area.
